Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **DSN HOLDINGS 980, INC.**, a Florida corporation (the "Corporation"), adopts the following Second Articles of Amendment to its Articles of Incorporation ("Amendment"):

**FIRST.** The date of filing the Articles of Incorporation was June 13, 2003 (Document No. P13000051628).

**SECOND.** The following amendment to the Articles of Incorporation was adopted by the Corporation:

Article I of the Articles of Incorporation of the Corporation is hereby amended as follows:

**"ARTICLE I - NAME.**

The name of this corporation shall be:

DSN Holdings 6650, Inc.

**THIRD.** Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

**FOURTH.** In accordance with Section 607.0123(2) of the Florida Business Corporation Act, this Amendment shall be effective upon filing with the Florida Department of State.

**FIFTH.** The foregoing Amendment to the Articles of Incorporation of the Corporation was approved by the shareholders of the Corporation by written consent on September 26, 2013, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act. The number of votes cast for the foregoing Amendment by the shareholders was sufficient for approval.
