

The undersigned desires to form a business corporation pursuant to Chapter 607 and adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Florida Beach Cottage of Naples, Inc.

ARTICLE II

The principal place of business and mailing address of the corporation will be 1112 12<sup>th</sup> Avenue North, Naples, Florida, 34102.

ARTICLE III

The corporation shall be organized for the transaction of any or all lawful business for which corporation may be incorporated.

The aggregate number of shares of stock which the corporation is authorized to issue shall be One Thousand (1000) shares of stock, no par value. Each share shall have equal voting rights and shall be of one class.


The number of registered agents thereafter shall be as the By-Laws of the corporation may provide from time to time.
