# ARTICLES OF INCORPORATION OF SAM KOSSEIFI, M.D., P.A.

The undersigned incorporator to these Articles of Incorporation, natural person competent to contract, hereby presents these Articles for the formation of a corporation under the Professional Corporation Act and other laws of the State of Florida.

### ARTICLE I

The name of this corporation is: SAM KOSSEIFI, M.D., P.A.

### **ARTICLE II**

The general nature of the business to be transacted by this corporation is: To engage in every phase and aspect of the business of rendering the same professional services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services within this State.

To invest the funds of this corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional services.
