ARTICLE III CAPITAL STOCK

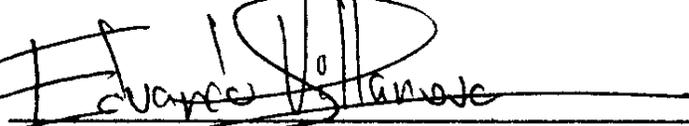
The aggregate of shares of sock and its value that this corporation is authorized to have outstanding at any one time is:
