**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF  
HEIDI ASHBAUGH, M.D., P.A.**

A. The name of the corporation is Heidi Ashbaugh, M.D., P.A. (the "Corporation").

B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on June 26, 2013.
