**ARTICLE I – Name**

The name of this corporation (the "Corporation") is **MARK FELDBERG PRODUCTIONS, INC.**

**ARTICLE II – Address**

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by the Florida Business Corporation Act.

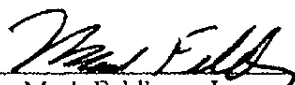
