**ARTICLES OF INCORPORATION
OF
4NiNE6, INC.**

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is 4NiNE6, Inc. (hereinafter called the "Corporation").

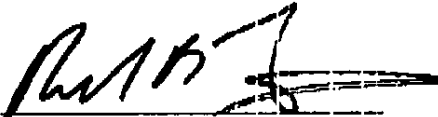

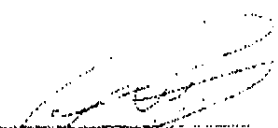
