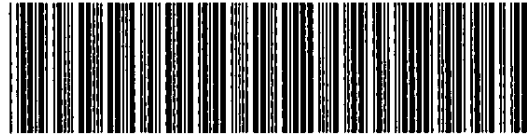

The undersigned subscriber, a natural person competent to contract, desires to submit these Articles of Incorporation for the purpose of forming a corporation in compliance with Chapter 607, *Florida Statutes*, as the same may from time to time be amended (the "Act").

ARTICLE I
NAME

The name of the corporation is PAPER ROOT, INC. (the "Corporation").

ARTICLE II
