This corporation is organized for the following purposes:

- (a) To engage in and carry on the practice of a licensed real estate agent through a professional corporation and to own and operate a real estate office for the purposes of providing real estate services.
- (b) To engage in every aspect and phase of the business of rendering real estate services to the general public and to do all things in connection therewith that are customarily done by licensed Real Estate Sales Agent under the laws of the State of Florida and in accordance with Chapter 621, Florida Statutes, "The Professional Service Corporation Act". Provided, however, that such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice said profession therein.
- (c) To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment and to own, lease, mortgage, and otherwise encumber real and personal property.
