**ARTICLES OF INCORPORATION
OF
BRH, INC.**

The undersigned hereby establishes the following for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation shall be BRH, Inc. (the "Company").

**ARTICLE II
PRINCIPAL ADDRESS**

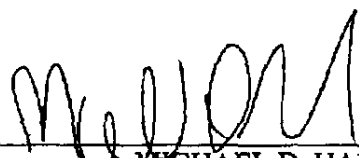
