**ARTICLES OF INCORPORATION OF**

The undersigned LAURINE CRANDALL, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, do hereby make and adopt the following Articles of Incorporation for such corporation:

**Article 1.** The name of the Corporation is: FLORIDA CLINICAL RESEARCH, INCORPORATED.

**Article 2.** The principal place of business and mailing address of the corporation is  
55 Westland Run, Ormond Beach, Florida 32174

**Article 3.** The duration of the Corporation is perpetual.

**Article 4.** The Corporation is organized, and shall be operated in a manner consistent with the authority granted by Chapter 607 of the Florida Statutes:

A. to have and exercise all rights and powers that are now or may hereafter be granted to Florida domestic corporations, without limitation.

B. to enter into and perform contracts of any kind necessary or incidental to the accomplishment of any one or more of the purposes of the corporation.

C. to grant and/or abate powers not inconsistent with law by publication of bylaws.

D. to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article 5.** The number of shares of stock that this corporation is authorized to have shall be 100 shares, valued at one dollar par.

**Article 6.** The street address of the initial Registered Office of the Corporation is 55 Westland Run, Ormond Beach, Florida 32174, and the name of its initial Registered Agent at that address is LAURINE CRANDALL.

**Article 7.** The Officers of the Corporation shall consist of a President, and such other Officers and Assistant Officers as may be provided in the Bylaws. Each additional Officer shall be appointed by the incorporator (and may be removed by the incorporator) at such time and in such manner as may be prescribed by the Bylaws. The name and address of each initial Officer of the Corporation is as follows:

**Article 12.** The Corporation shall indemnify each Officer and Trustee, including former Officers and Trustees, to the full extent permitted by the laws of Florida.

**Article 13.** In accordance with Florida Statute, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.
