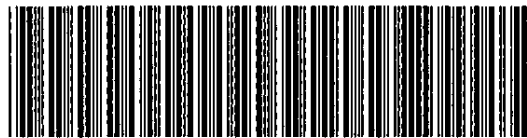

**ARTICLES of INCORPORATION of

The undersigned, acting as sole incorporator of Green Swamp Systems Inc. under Chapter 607 of Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

Article I – Name

The name of the corporation shall be: Green Swamp Systems Inc.

Article II – Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, once cent (\$0.01) par value per share.

Article III – Principal Office

The Address of the Principal Office of the corporation is 6850 Green Swamp Road, Clermont, FL 34714. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the corporation.


Article VI – Initial Board of Directors


