1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on July 19, 2013, Articles of Correction were filed on August 15, 2013, and Articles of Amendment were filed on March 2, 2021.

2. Pursuant to Section 607.1003, Florida Statutes, this amendment to the Articles of Incorporation was adopted by unanimous written consent of the shareholders of the common stock of the Corporation as of April 8, 2021 and the number of votes cast by holders of the common stock was sufficient for approval. In addition, this amendment was approved by unanimous written consent of the board of directors of the Corporation as of April 8, 2021.

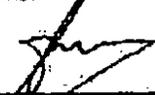

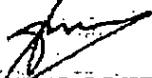
