To be a promoter, incorporator, partner, member associate, or manager of any corporation, partnership, joint venture, trust; or other enterprise;

To have and exercise all powers necessary of convenient to affect its purposes:

To indemnify any person who by reason of the fact that he is or was a director, officer, employee or agent of the corporation to the full extent as permitted by Florida Statuts \$607.014;
