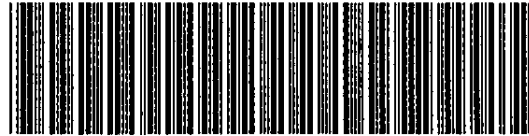

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is SOAPBOX BARTLEY, INC. Its principal office address and business mailing address is 300 Bartley Rd., Daytona Beach, FL 32114.

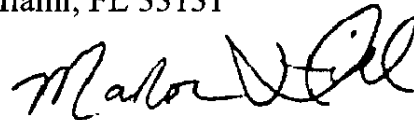
