ARTICLE I - CORPORATE NAME

The corporate name for the Corporation (the "Corporation") is DORAL FLEX TWO CORP.

ARTICLE II - STREET ADDRESS

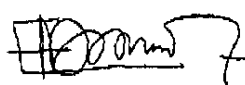
