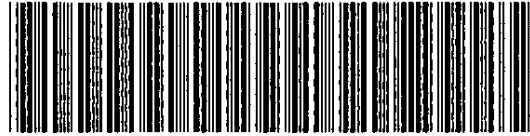



ARTICLE I - NAME

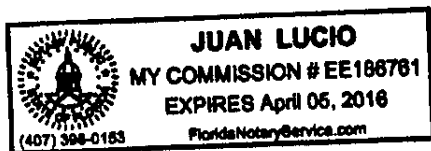
