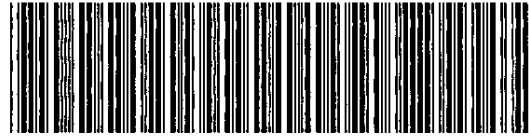


Mr. Yarbrough,



