ARTICLES OF INCORPORATION

FLORIDA REALTY AND DEVELOPMENT, INC.

ARTICLE I - NAME

The name of this corporation is Florida Realty and Development, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE IV - POWERS

This corporation shall have all of the corporate powers permitted under the Florida Business Corporation Act.

The shareholders reserve the power to adopt by laws and to prescribe in any by-laws that such by-laws shall not be altered, amended, or repealed by the Board of Directors.
