Pursuant to the provisions of Section 607.1006, *Florida Statutes*, the undersigned Florida corporation adopts the following amendment to its Articles of Incorporation.

1. Article I of the Articles of Incorporation of Chicken Pantry of America, Inc. is hereby amended in its entirety to read as follows:

"ARTICLE I

Name and Duration

The name of the Corporation is Dunsmoor Investments, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State."

2. The amendment was approved by the incorporator without board of directors or shareholder approval, which was not required.
