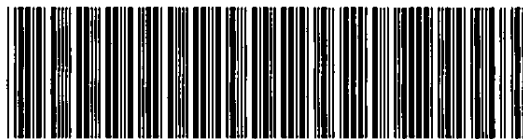

ARTICLE 1

DURATION
