# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF VEHLTOR FLORIDA, INC. P13000049579

Pursuant to the Florida Business Corporation Act, Chapter 607 of the Florida Statutes (the "FBCA"), Vehltor Florida, Inc., a Florida corporation (the "Corporation"), hereby certifles that:

FIRST: The Corporation was originally incorporated in the State of Florida on August 21, 2013, and these Amended and Restated Articles of Incorporation shall amend, restate, and supersede in their entirety any and all prior Articles of Incorporation (and all amendments and modifications thereto) filed with the State of Florida from the date of the Corporation's original incorporation through the date hereof.

SECOND: These Amended and Restated Articles of Incorporation were approved by all members of the Board of Directors of the Corporation on September 30, 2013, and approval by the shareholders of the Corporation was not required as no shares of stock of the Corporation have yet been issued.

THIRD: The Corporation's Articles of Incorporation, as amended, are amended and restated as follows:

### ARTICLE I NAME AND ADDRESS

The name of this Corporation is Vehitor Florida, Inc. The address of the Corporation's principal place of business is 825 SE 3<sup>rd</sup> Avenue #200, Ocala, Florida 34471. The mailing address of the Corporation is 303 SE 17<sup>th</sup> Street #309 Suite 206, Ocala, Florida 34471.

#### ARTICLE II TERM OF EXISTENCE

This Corporation shall have perpetual existence.

### ARTICLE III PURPOSE

The purpose of this Corporation is to engage in any and all lawful business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV SHARES AND SHAREHOLDERS

The number of shares of capital stock which the Corporation shall have the authority to issue shall be 100,000,000 shares of Common Stock, no par value.
