**ARTICLES OF INCORPORATION
OF
SUMMIT VISTA MERGER CORPORATION**

The undersigned, acting as incorporator of Summit Vista Merger Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation shall be Robinson & Old Trail Road, New Providence, Bahamas.

ARTICLE III. COMMENCEMENT OF EXISTENCE


