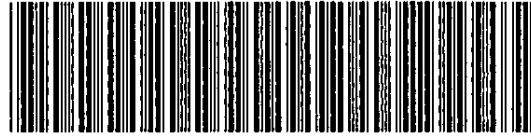

Dear Mr. Burch,

I created a corporation called Morgado Legal PA in 2009. It was administratively dissolved in 2011. On August 12, 2013, I applied to reinstate Morgado Legal PA. When I received the confirmation email, I decided not to reinstate the corporation but to instead create a new corporation by the same name. I was told that as long as I did not respond to the confirmation email regarding reinstatement, I would be able to create the new entity. On August 20, I received a letter saying that the name Morgado Legal PA was unavailable due to a pending application for reinstatement by an entity with the same name. I spoke with someone from the Reinstatement Office this afternoon and explained that I wish to abandon the application for reinstatement. She then informed me that the name Morgado Legal PA is now available. I wish to create a new corporation in this name.




