ARTICLES OF INCORPORATION

The undersigned acting as incorporators of a corporation under the Florida General Corporation act adopts the following Articles of Incorporation for their corporation.

ARTICLE I

The name of the corporation shall be ALLEN LEE ENTERPRISES, INC., whose principal place of business is 1475 Ocean Breeze Drive, Marathon, FL 33050, and its mailing address 1475 Ocean Breeze Drive, Marathon, FL 33050.

ARTICLE II

The period of duration of the corporation is perpetual.

The sum of the par value of all shares of the capital stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time. 
ARTICLE IX


