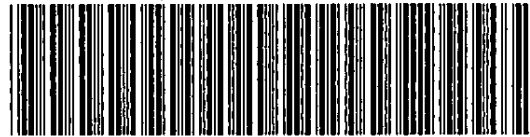



ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is J & J RESTORATION INVESTMENTS, INC. and its principal place of business shall be located at 716 Parrot Court, Kissimmee, FL 34759..

ARTICLE II - DURATION

ARTICLE XI - AMENDMENT


This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, and any right conferred on the shareholders is subject to this




