

Dear Ms. Herring:

I am writing to you regarding the above-referenced matter, as the attorney for Gloria Buhler and Segovia Oaks, Inc., and as attorney and registered agent for Segovia Oaks, LLC.

I understand that you spoke with Gloria Buhler (who is also my wife). Pursuant to the documents attached hereto, Gloria Buhler sought to set up a Florida corporation, Segovia Oaks, Inc. We previously created Segovia Oaks, LLC which was transferred to the ownership of Newport World, Ltd. As she discussed with you on the phone, Gloria Buhler subsequently determined that for the purposes of the business that she is creating, the entity needs to be a corporation rather than an LLC. She therefore sought to create a separate Segovia Oaks, Inc. but was advised that because Segovia Oaks, LLC already exists the name cannot be used for a corporation.

We further understand pursuant to a conversation with you that so long as the beneficial owners are the same the LLC can be converted to a corporation. For that reason I am writing to confirm to you that Segovia Oaks, Inc. will be owned by Newport World, Ltd., the entity that now owns Segovia Oaks, LLC. In essence, if we are able to convert Segovia Oaks, LLC to a corporation nothing else need be changed.

We are returning herewith the documents that you returned to us and ask if we can merely convert the LLC to the corporation. We trust this will be sufficient and therefore hope to receive certified confirmation of the existence of Segovia Oaks, Inc. so that we can proceed to transfer real property to the corporation as soon as possible.
