Pursuant to our phone call of today, I am verifying for you that I am the incorporator of the new corporation DeCarlis & Sawyer, PA, originally incorporated by me on-line on April 20th, 2013, approval code 286880, document number W13000023218, set to begin business on May 1st, 2013.

I received an email two days later from Justin Shivers in your office noting that an LLC titled DeCarlis & Sawyer, PL, document number L09000001730, was still an operating Florida entity, and the names were too close for him to approve the new PA corporation to begin business under that name. 
Pursuant to my call yesterday to an operator there and my discussion with you today, I am verifying that I am also the Managing Member of the LLC DeCarlis & Sawyer, PL. We are changing the name and opening the new corporation due to personnel changes within the firm and compliance with Florida Bar regulations. For compliance with the Florida Business Act and tax implications, we must keep the PL company operating for a time to insure a proper wind-down. However, we plan to shift primary operations to the new PA as of October 1st, 2013.

My understanding is that with this declaration of ownership and incorporation status we are now ok to go forward with this planned procedure as described above.
