**ARTICLES OF INCORPORATION
OF
OMH GROUP, INC.**

THE UNDERSIGNED, acting as sole incorporator of OMH Group, Inc. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation, pursuant to Section 607.0201 of the FBCA:

ARTICLE 1

Name

The name of the Corporation is: OMH Group, Inc.

ARTICLE 2

Principal Office and Mailing Address

The address of the principal office of the Corporation is 721 South Oregon Avenue, Tampa, Florida 33606 and its mailing address is 721 South Oregon Avenue, Tampa, Florida 33606. The location of the principal office and the mailing address shall be subject to change as may be provided in the Bylaws.

ARTICLE 3

Capital Stock

The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 1,000 shares, all of which shares shall be denominated "Common Stock," having a par value of \$0.001 per share. Pursuant to Section 607.0602 of the FBCA, the Board of Directors is authorized, without the approval of the shareholders of the Corporation, to (a) provide for the classification and reclassification of any unissued shares of common stock or preferred stock and determine the preferences, limitations, and relative rights thereof and (b) issue common stock or preferred stock in one or more classes or series, all within the limitations set forth in Section 607.0601 of the FBCA.


Initial Registered Office and Agent
