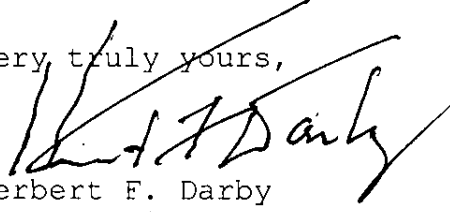

ARTICLES OF INCORPORATION
OF

WEN-ONE OF FLORIDA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
NAME AND PURPOSE

The name of the Corporation ("Corporation") is WEN-ONE OF FLORIDA, INC. The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE II
EXISTENCE

The existence of the Corporation shall begin upon the filing of these Articles of Incorporation.

ARTICLE III
PRINCIPAL OFFICE

The street address of the principal office of the Corporation is 134 SE Colburn Avenue, Lake City, Florida 32025.

ARTICLE IV
SHARES

The maximum number of shares this Corporation is authorized to issue is 100,000, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

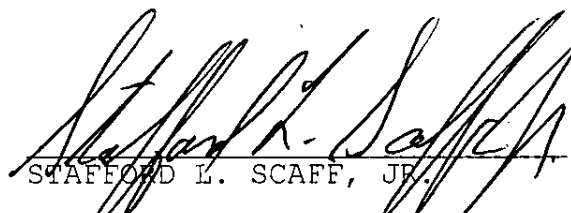
