ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Saloote Inc. Its principal office address and business mailing address is 175 SW 7th Street, Suite 1617, Miami, Florida 33130.

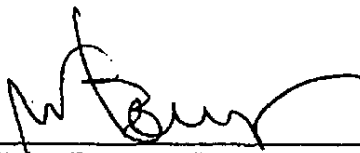

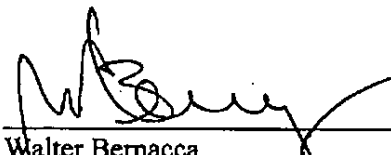
