ARTICLES OF INCORPORATION OF

A Florida Corporation

ARTICLE I. NAME

The name of this corporation shall be:

IOE CORPORATION

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be on October 1, 2013. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of operating an electronic engineering and marketing business. This corporation may engage in the transaction of any and all business activities permitted under the laws of Florida and the United States of America.

ARTICLE IV. COMMON CAPITAL STOCK

This corporation shall have the authority to issue Two Thousand (2,000) shares of common capital stock having no par value.

ARTICLE V. RESTRAINT ON ALIENATION OF SHARES

The shareholders of the corporation shall have the power to include in the Bylaws, or by separate agreement adopted by a majority of the shareholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the corporation by any of its shareholders, or in the event of the disability, divorce, or death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the shareholders of the corporation. Provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the

No shareholder of the corporation may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose.

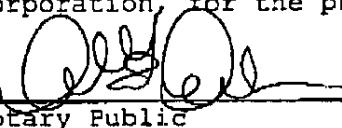

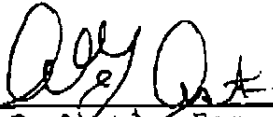

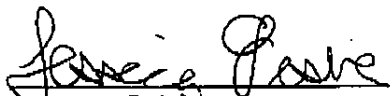
