#### ARTICLES OF INCORPORATION OF

The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

## <u>ARTICLE I. NAME</u>

The name of the corporation is Programmatic360, Inc. (the "Corporation").

# ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

#### ARTICLE III. DURATION AND COMMENCEMENT

#### OF CORPORATE EXISTENCE
