

Article of Incorporation of Paradise Outdoor, Inc. A Florida Corporation

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

<u>ARTICLE I</u>

The name of the corporation shall be: Paradise Outdoor, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation is: any and all activity or business permitted under the laws of the United States and the State of Florida, including but not limited to pool construction & maintenance.

A<u>RTICLE III</u>
