OF

ARTICLE 1

NAME

The name of the corporation is CES Acquisitions, Inc. (the "Corporation").

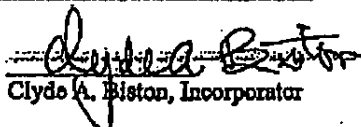

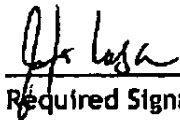
