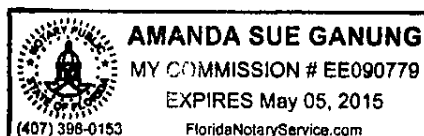
1. Introduction. Delbert Hobdy, being duly sworn, deposes and says:
