ARTICLES OF INCORPORATION

of

SNAPPRINTS INC. (A Florida Corporation)

The undersigned, desiring to form a corporation in the State of Florida pursuant to Chapter 607, F.S., hereby certifies:

ARTICLE I - NAME

The name of the corporation shall be SnapPrints Inc., hereinafter referred to as the "Corporation."

ARTICLE II - ADDRESS

The principal street address and mailing address of the Corporation is 5450 Windsor Lake, Sanford, Florida 32773.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV - INITIAL BOARD OF DIRECTORS

The Corporation shall have a Board of Directors initially comprised of one director. The number of directors may be increased or decreased from time to time by an amendment to these Articles or in the Shareholders' Agreement of the Corporation in the manner provided by law but shall never be less than one. The name and address of the initial director of the Corporation is Christopher Duroseau, 5450 Windsor Lake, Sanford, Florida 32773.

ARTICLE V - CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1000) shares at a par value of one dollar (\$1).

ARTICLE VI - REGISTERED AGENT

The Registered Agent of the Corporation shall be Veronica Valdez. The address of the Registered Office is 390 N. Orange Avenue, Suite 2300, Orlando, Florida 32801. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 607 F.S. regarding the same.

ARTICLE VII - DURATION

The Corporation's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved by operation of law or: (i) in accordance with the Shareholders' Agreement of the Corporation, or (ii) upon unanimous written consent of all the shareholders.

ARTICLE VIII - AMENDMENT

These Articles may be amended as provided in the Shareholders' Agreement of the Corporation, or in the manner provided by law if there is no Shareholders' Agreement. Every amendment shall be approved by the Board of Directors and approved at a shareholders meeting by a majority of the shares entitled to vote thereon.

ARTICLE IX - INCORPORATOR
