The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

# ARTICLE I - NAME

The name of the corporation is N<sup>3</sup> Contracting, Inc.

#### ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

# **ARTICLE III - NATURE OF BUSINESS**

This corporation is organized for the purpose of **roofing**, **general contracting** and any other activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE IV - AUTHORIZED SHARES

The initial Board of Directors shall consist of **three (3) members** who need not be a resident of the State of Florida or a shareholder of the corporation.
