ARTICLES OF AMENDMENT
FIRST COAST ACUPUNCTURE INSTITUTE, P.A.
TALLAHASSEE, FLORIDA

These Articles of Amendment are filed pursuant to Florida Statute §607.1006, to reflect an amendment to the Articles of Incorporation of First Coast Acupuncture Institute, P.A. (the "Corporation") and in connection therewith, the undersigned officer acting upon authority of the Board of Directors of the Corporation, hereby sets forth as follows:

1. The name of this corporation is First Coast Acupuncture Institute, P.A.
2. The Articles of Incorporation of First Coast Acupuncture Institute, P.A. have been amended by deleting Article I, Name, in its entirety and replacing it with the following:

The name of this Corporation is Neuromuscular Pain Institute, P.A.

3. The Articles of Incorporation of First Coast Acupuncture Institute, P.A. have been further amended by deleting Article II, Nature of Business, in its entirety and replacing it with the following:

The general nature of the business to be transacted by this Professional Service Corporation is:

To engage in every phase and aspect of the business rendering professional services to the public that a licensed physician is authorized to render under the laws of the State of Florida, including, but not limited to medical services, acupuncture, and related services thereto. However, no professional services shall be rendered by this Corporation except through its officers, employees, and agents who are duly certified, registered or licensed or otherwise legally authorized to render such professional services within this State.

The general nature of the business to be transacted by this Professional Service Corporation as described in this Article II is intended to comply with Florida Statutes Section 621.

4. In accordance with Florida Statute §607.1003, the referred to amendment was adopted by the Board of Directors on August 18, 2015, and written consent to the said Amendment was given on August 18, 2015 by the sole stockholder of the Corporation comprising the only voting group in accordance with Florida Statute §607.0704. The number of votes cast for the Amendment by the stockholder is sufficient for approval of the Amendment by all voting groups of the Corporation.
5. Upon the filing of these Articles of Amendment by the Department of State, the above referred to amendment shall become effective and the Articles of Incorporation of First Coast Acupuncture Institute, P.A., shall be deemed to be amended accordingly.
