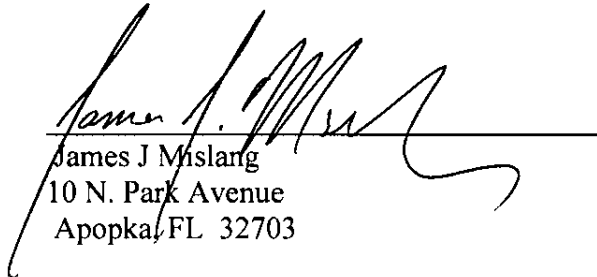
**NOTICE OF RESIGNATION OF JAMES J MISLANG AS PRESIDENT AND

The undersigned authorizes the Corporation to record this document with the appropriate state agencies and/or departments to effectuate the above.

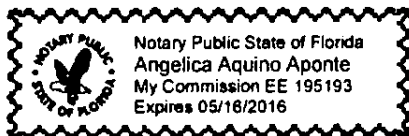
