**ARTICLES OF INCORPORATION  
OF  
FULTON FORSYTH HOLDING CORP**

The undersigned, acting as incorporator of Fulton Forsyth Holding Corp under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation is Fulton Forsyth Holding Corp (the "Corporation").

**ARTICLE II - ADDRESS**

The street address of the principal office of the Corporation is:

**ARTICLE III - PURPOSE**

The Corporation is organized for the purpose of performing lawful business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - DURATION AND EXISTENCE: EFFECTIVE DATE**

The Corporation will exist perpetually. These Articles of Incorporation shall be effective as of October 24, 2013, unless the filing of these Articles of Incorporation occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

**ARTICLE V - AUTHORIZED SHARES**

The maximum number of shares the Corporation is authorized to issue is 1,000 shares of common stock having a par value of \$1 per share.

**ARTICLE VI - REGISTERED AGENT AND OFFICE**

The Corporation hereby (i) designates One Independent Drive, Suite 1200, Jacksonville, Florida 32202 as the street address of the Corporation's registered office, and (ii) names Contega Business Services, LLC as the Corporation's registered agent at that address to accept service of process within the State of Florida.

**ARTICLE VII - BOARD OF DIRECTORS**

The number of directors may be increased or decreased from time to time, as provided in the Corporation's bylaws, but shall never be less than one (1).
