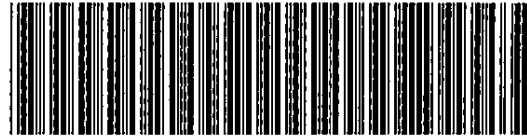

The undersigned, acting as incorporator of NANCY POND HALULA, P.A., under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

EFFECTIVE DATE 10/18/13
