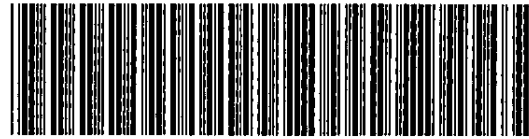

The undersigned hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida

ARTICLE I
Name

The name of the corporation shall be **BODY BUTTER BOUTIQUE, INC.**

ARTICLE II
Principle Place of Business/Mailing Address

ARTICLE III
Purpose

The general nature of the business to be transacted by this Corporation is Retail. This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida

ARTICLE IV
Capital Stock

The total number of shares of capital stock authorized to be issued by the corporation shall be 100 shares having a par value of \$1.00 per share. 50% OWNERSHIP OR 50 SHARES TO MICHAL L. HONEL, DIRECTOR
