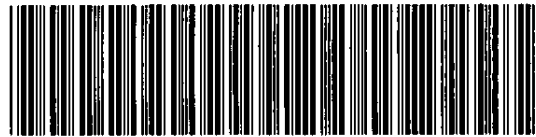

**ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be Jefferson Bshares, Inc. (the "Corporation"). The Corporation's initial place of business and mailing address shall be 3711 Tampa Road, Oldsmar, Florida 34677.

**ARTICLE II**

The general nature of the business to be transacted by the Corporation shall be any permissible under the Laws of the United States of America and the State of Florida.

**ARTICLE III**

The total number of shares authorized to be issued by the Corporation shall be 10,000,000. Such shares shall consist of 9,000,000 shares of common stock with \$5.00 par value per share, and 1,000,000 shares of undesignated preferred stock.


**ARTICLE IV**

The term for which said Bank shall exist shall be perpetual.

**ARTICLE V**

The number of directors shall not be fewer than five. A majority of the full board of directors or of the shareholders may, at any time during the year following the annual meeting of shareholders, increase the number of directors by not more than two directors, and appoint persons to fill resulting vacancies.

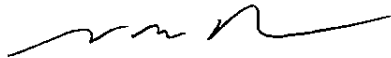
