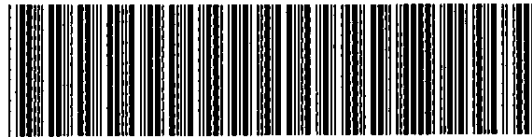

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is **CENTRAL FLORIDA BUILDING AND REMODELING, INC.**

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE


