## ARTICLES OF INCORPORATION OF NT INTERIM BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the laws of the State of Florida, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be NT Interim Bank and its principal place of business shall be 315 East Robinson Street, Suite 100, Orange County, Orlando, Florida 32801.

#### ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.
