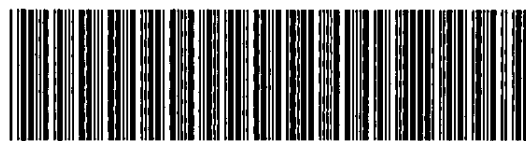

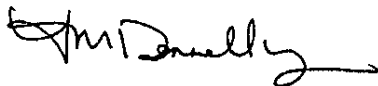

1. Tina M. Donnelly is the duly elected and acting Secretary/Treasurer /Chief Financial Officer/Director of the Corp. herein above named.
2. The Articles of Incorporation. shall be read in full as follows:

ARTICLE I.

The name of the Corp. shall be PurpleRack.com, Corp. and shall be governed by Title XXXVI Chapter 607 of the Florida Statutes.

ARTICLE II.

The nature of the business shall be to engage in any and all lawful activity permitted by the laws of the State of Florida and desirable to support the continued existence of the Corporation.

The Corp. shall have the power to conduct its business both within and outside the State of Florida.

ARTICLE III.

The principal office of the Corp. shall be: 6371 Business Boulevard, Suite 200, Sarasota, FL 34240.

ARTICLE IV.

The total authorized capital stock of the Corp. shall be Five Hundred Million (500,000,000) shares of common stock with a par value of \$.01 per share, all or any part of which capital stock may be paid for in cash, in property or in labor and services at a fair valuation to be fixed by the Board of Directors. Such stock may be issued from time to time without any action by the stockholders for such consideration as may be fixed from time to time by the Board of Directors, and shares so issued, the full consideration for which has been paid or delivered shall be deemed the fully paid up stock, and the holder of such shares shall not be liable for any further payment thereof. Each share of stock shall have voting privileges and will be eligible for dividends.

There shall be one class of preferred blank check stock to be issued solely at the discretion of the Board of Directors.

ARTICLE V.

The Corp. shall have perpetual existence. The date when the Corporation existence shall commence is October 30, 2013 upon the filing of the original articles of Incorporation.

ARTICLE VI.

The registered agent and the office of the resident agent shall be:
