**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Kforce Training Systems Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: Kforce Training Systems Inc.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at 12:01 A.M., the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the current registered office of the corporation is 1200 South Pine Island Road, Plantation, Florida 33324, and the name of the corporation's current registered agent at that address is CT Corporation System.


ARTICLE IX. BYLAWS


