

ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

13 NOV -4 AM 8: 23

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a for profit corporation under the Business Corporations Act and other laws of the State of Florida.

ARTICLE I

The name of the corporation is **GOIN' POSTAL JACKSONVILLE CHAFFEE**, **INC.**This corporation will exist perpetually.

ARTICLE II - PRINCIPAL OFFICE

The principal office of the corporation is: 1523 Chaffee Road South, Unit 12, Jacksonville, Florida 32221. The principal office may be moved to any address that the Board of Directors will choose, provided however that the principal office will be in the State of Florida. The mailing address of the corporation will be the same.

ARTICLE III -- PURPOSE

The general nature of the business that will be transacted by the corporation includes the professional sale of postal products and services as allowed by Florida Law.

The corporation will have the power to invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the operation of the corporation's business.

The corporation will have the power to do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects for the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendments hereto, and either alone or in association with other corporations, firms, or individuals, to carry on any

lawful pursuit necessary or incidental to the accomplishment of the purposes and objects of this corporation.

The foregoing enumeration of objects and purposes will not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE IV -- SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having no par value. Shareholders will not have preemptive rights. The shareholders may, by bylaw provision or by shareholders' agreement, impose such restriction(s) on the sale, transfer, or encumbrance of the stock of this corporation, as they may see fit.

ARTICLE V – INITIAL OFFICERS AND/OR DIRECTORS

The initial officers and/or number of directors of the corporation will be two (2). The number of directors may be changed by the bylaw adopted by the shareholders, provided however that the number of directors will never be less than one (1). The initial officers and/or directors are:

No contract or other transaction between this corporation and any other corporation will be affected by the fact that any director of this corporation is interested in or is a director or officer of such other corporation. Every person who may become a director of this corporation is hereby relieved from any liability that might otherwise exist from contracting with this corporation for the benefit of himself or any firm, association, or corporation in which he may be interested in any way.

This corporation will have the power to enter into, for the benefit of its employees, one or more of the following: (1) a pension plan, (2) a profit-sharing plan, (3) a stock bonus plan, (4) a thrift and savings plan, (5) a restricted stock option plan, (6) health insurance plan, (7) a life insurance plan, other retirement or incentive compensation plans. This corporation will have the power to make loans, secured or unsecured, to its shareholders, providing said shareholders are active employees of the corporation.
