**ARTICLES OF INCORPORATION**  
**OF**

**ARTICLE I - NAME**

The name of this S-corporation is Epiphany Leads, Incorporated.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business as a management consulting firm serving primarily non-profit organizations.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

**ARTICLE V - PRE-EMPTIVE RIGHTS**


#### **ARTICLE IX - INDEMNIFICATION**

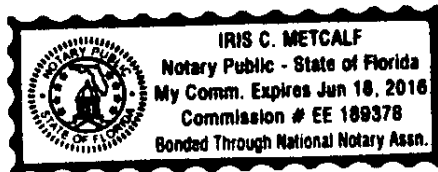




